

## **Official Rules and Regulations – Creekwood Christmas Lights Contest 2017**

No purchase is necessary to enter or to win the 2017 Creekwood Christmas Lights Contest. The act of entering the Contest constitutes acceptance of the Contest rules & regulations (and all decisions of Delcon Creekwood V Ltd., Delcon Creekwood VI Ltd. and Delcon Creekwood Master GP Ltd. and its agents).

To be eligible for our Grand Prize Draw, entrants must have their Christmas lights on display on the evening of Monday, December 11, 2017 from 5:00PM-7:30PM, as they will be reviewed by a panel of judges that evening and grand prizes awarded to our top 2 selections based on a number of criteria including aesthetics, best use of space, etc. If a homeowner is not home during the hours of 5:00PM-7:30PM on the evening of December 11<sup>th</sup>, we will award the prize to our next runner-up and so on and so forth until all grand prizes have been awarded.

To be eligible for our People's Choice Award, entrants must submit a photo of their lights display on the Creekwood Chappelle Facebook Page starting December 11 until December 17. On December 12, Creekwood Chappelle will post a photo album on the Creekwood Chappelle Facebook page of photos of the most stand-out homes with light displays taken the previous evening. However, we encourage participants to set up their displays prior to December 11 and submit their own photos to the Creekwood Chappelle Facebook page, which will then be added to the photo album on an ongoing basis until December 17. From there, Facebook users will be able to like and comment on their favourite displays and the home that collects the most likes, comments, shares by midnight on December 18<sup>th</sup>, 2017 will win the People's Choice Award.

1. You must be a legal resident of the Province of Alberta to enter. 8. The winner of our Grand Prize Awards and People's Choice Award will be required to sign and return a declaration and release form within 10 business days of notification by Creekwood. If the winner fails to comply, a new winner will be selected. Prizes must be claimed by January 30, 2018, or they will be void.
